Dear JJAFU members,

I, the undersigned JJAFU Executive President, hereby invite all of you on behalf of the JJAFU board, for our Elective General Assembly (GA) to be held beside our African Championships 2016 and the Technical/Referee courses, from the 17th to the 21st of August 2016 in BENONI South-Africa.

Following the JJIF special authorization and JJAFU Board decision, all the positions in our Executive Board are officially opened for candidatures, till the 30th of June 2016 at 12 pm. At the same time, the contribution to the Agenda of the GA (already open) will continue till the same deadline. The board has also decided to allow participations by proxy as well as through others communication media.

The official application form for candidacy will be forwarded to you by the JJAFU General Secretary (GS), whose email address (pierresamobo@yahoo.fr) will also be used as the official one for sending your applications, documents and contributions.

The election process will mainly based on the actual JJAFU statutes; however, the following important elements linked to the new JJIF reforms are to be taken into consideration:

- The five vice-presidents to be elected from each JJAFU region, are no more the Regional presidents;
- After the Board's election, will be the election of the JJIF/JJAFU regional representatives;
- Despite the 6 months granted to the Continental Unions to conform with the new JJIF statutes, it is very important to have everything ready as soon as possible for the JJIF application to the CIO. Consequently, a committee will soon be set up by the JJAFU board, in order to study both statutes and propose needed changes for approval by the GA after the election process.
